## HALL OF FAME

### Hall of Fame

The Pinto Horse Association believes in honoring outstanding individuals that have impacted the past, present and future of the Pinto breed and the association that is dedicated to preserving and promoting it. Therefore, PtHA takes great pride in its Hall of Fame program which now includes four separate categories: Judge, Equine, Individual and Professional Horseman/Horsewoman of the Year and Amateur Master.

Any PtHA member is welcome to nominate a judge, equine, individual or Professional Horseman/Horsewoman or Amateur Master for Hall of Fame status. Nominations will be accepted yearly and must be postmarked by September 1st. If nominees are not selected for induction, they will remain on the selection ballot for two additional years after the first nomination. If, after three years, the nominee still has not been selected for induction, they will be removed from the ballot and will not be eligible for nomination for three years.

Listed below are the criteria for each Hall of Fame category.

### Individual

1. May be living or deceased.
2. Should have been a PtHA member if his/her activities were during the existence of the PtHA.
3. Must have been outstanding over a period of years either as a breeder, competitor or contributor to the PtHA.

### Amateur Master

1. May be living or deceased.
2. May be an active amateur or be retired.
3. Must have been a PtHA amateur for at least ten years.
4. Must have shown at Pinto World Championship Show, Color Breed Congress and Charter Shows.
5. Must have been active in local shows and PtHA activities.

### Equine

1. Must be deceased.
2. Must be registered with PtHA.
3. Must have been outstanding over a period of years as a sire, dam or competitor. Or, must have brought exceptional visibility to the PtHA.

### Judge

1. May be living or deceased.
2. May be an active judge or be retired.
3. Must have been a carded PtHA judge for at least ten years.
4. Must have judged a minimum of twenty approved PtHA shows.
5. Must have officiated at least one of the following: Pinto World, National or International Championship Show, Pinto Congress and Futurity Show, Color Breed Congress, Area Championship Show, Regional Show, Breeder's Cup, Jubilee Show, Benefit Show.

### Professional Horseman or Horsewoman of the Year

1. Must be a current member in good standing of PtHA and a professional horseman or horsewoman.
2. Must be involved and support the local, state and national level events and organization, including service to PtHA.
3. Must be one who has worked toward the future of our industry thru ethical, positive and innovative endeavors.
4. Will be recognized for their efforts and/or achievements that enhance the equine industry, foster credibility, show superior industry standards or otherwise demonstrate extraordinary contribution to the breed and the equine field as a whole.
