- International/Amateur/Registration Department – Emily Wolf reported registrations were up in 2023, including the field rep registrations. Transfers were down. Awards that were not used at world show will be

repurposed for 2024. We will be expanding youth novice at world show to Jr and Sr., each will have their own awards. Also expanding open mini high point, award for A and B open high points will be a cart.

- Magazine/Marketing/Media/Youth/Partners – Jenna Henson reviewed all the social media statistics for Facebook, Instagram, Youtube and the website. All numbers are up. She reviewed our current partners. She highlighted our involvement with Betterhorses.com. Jenna announced the PWC will continue to host the Youth Weekend prior to the show starting. This will include a day of Youth Speech Contests and a day of Horse Judging.

- Performance/Show Department – Caitlyn Uehling reviewed the Pinto World Championship and Color Breed Congress numbers and the local shows.

- Judges Committee – Kim Hall reported they had 11 applications in 2023, 10 were asked to attend the testing process in 2024. We had 8 that were able to attend, 3 that passed and have received their PtHA Judge cards.

- IT Department – Kim Hall reported they are in the process of updating the database system in the office. We have purchased all new computers and workstations for the office. Security cameras have been placed inside and outside the office.

Pinto Heritage Foundation Report – Ann DiGiovanni reported the Foundation is financially sound. They are giving away 9 scholarships this year. Encouraged everyone to support the auction this evening. Motion made by William Sparr, seconded by Ron Bartholomew to accept the report, motion passed.

Recommendations:

- Work on ways to promote OCAP and On the Trail programs

- Look into adding a Scribing seminar to the convention
- Check into adding a Rookie of the year for Youth and Amateur
- Negotiate a 3-year contract with the Embassy Suites, Airport, OKC for the convention
- Work on filling the Board of Director vacancies
- Send emails to members from the past 3 – 5 years letting them know we miss them
- Increase the number of charters, one in every state is a goal
