**Justification: Due to the ever changing dynamics of the Pinto shows the viability of achieving higher PtHA awards

are no longer equal to obtain. All types of horses are no longer on an equal playing field. For example: Utility horse classes

are not offered at the Pinto World Show or Congress Show. Saddle and Pleasure type classes have been cut to a minimum resulting

in few entries and point viability at the Pinto World show and are not offered at the Congress show. Jubilee shows are

few and far between and not all of these shows offer classes for all the different types.

Impact if not passed: A continued decline in entries and loss of revenue.





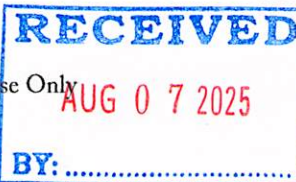

Originator's justification and impact if not passed: current scale is cost prohibitive to exhibitors due to today's financial climate thus prohibiting smaller show participation

Proposal: change point system to add points for 2 or fewer class entries and allow all approved show classes to receive points regardless of amount of individual entries or single entry class. Point sliding scale change to 2 or fewer-1st-1point, 2nd-no point/ 3 entries -1st-2points, 2nd-1 point/ 4 entries-1st-3points,2nd-2points,3rd-1 point,/ 5 entries-1st-4pts, 2nd -3-pts,3rd-2pts., 4th-1 pts./ 6 entries-1st-5pts 2nd-4pts,3rd-3 pts, 4th-2 pts, 5th-1 pt/7 entries-1st-6pts,2nd-5 pts, 3rd-4 pts,4th-3 pts, 5th -2 pts,6th-1 pt /8 or more entries- 1st-7 pts, 2nd 6pts, 3rd-5pts, 4th-4pts, 5th-3pts,6th-2 pts,7th- 1pt.

Reason for this is because the price of gas and costs involved with showing in general has risen greatly. Exhibitors are trying to support their regional and national shows. Exhibitors should not be penalized with no points awarded if they have spent the time and money to support a show and they are the only one in the class. It is not their fault and the situation is out of their control as to how many entries show up. In order to support the smaller and/or zone shows, who depend on entries to survive, it would behoove the association to allow the exhibitor to have the opportunity to receive points for all classes available no matter the amount of entrants in each class. It supports the smaller shows with money and participation and supports the member who is striving for end of the year or zone pinto awards. The proposed point scale does not hurt or change any other aspects of our show rules other than to give exhibitors that have taken an interest in Pintos, supporting the association thru their dues, and showing their Pinto, the opportunity to compete in a class and receive a point even if they are a single entry. The lone exhibitor in a class has the same expenses as everyone else with 3 or more entries in a class and should't be discriminated against just because there is only 1 entry and that determination ultimately is out of their control until show entry deadline.They are supporting the show just like a bigger class and should be rewarded for their dedication, effort, time, money, and support of the horse showing industry. Times have changed and everybody's money is at a premium. not only for exhibitors but for shows to prosper and continue as well.
