Any duplicate certificate issued without the PtHA of the original registration certificate of documentation and verification of its absolute and previous invalidation will be marked "Duplicate Certificate Issued. Subject to Cancellation."

The certificate is the property of the PtHA and any alterations of information, signatures, numbers, photographs, etc., or failure to complete any transfers, advancements, and/or reclassifications within applicable time limits will render the certificate in- valid. Any certificate that is written upon, mutilated, damaged, soiled, staples, punched, or otherwise altered becomes an invalid document, mandating that a duplicate certificate be issued.

The PtHA office will complete within four to six weeks of receipt of this application with the following items:

1. \$25.00 Duplicate Certificate fee for members, \$75.00 for non-members. (Paid in U.S. funds)
2. Four current color photos including one full frontal view, one full rear view, one left side and one right side. All photos must include all parts of the animal available in each view (i.e. ears to hooves and nose to tail) and be unobstructed by any other horses, handlers, riders, tack (other than a halter and lead), foliage, or fences in the foreground.
